Instructions for Floor Mat Care and Usage

Failure to follow care instructions may void the warranty.

You may notice small wrinkles on the top surface and outside edges of your floor mat. These are a normal result of packaging and shipping. Wrinkles will relax and smooth out over time.

If the mat is slipping on a hard surface floor, lightly and spray water to wet the underside of the mat and place on the floor. This will create a light suction effect to prevent slipping. Only do this if your floor will not be damaged by water. Alternately you can place a non-slip safety rug floor gripper pad beneath the floor mat to prevent moving. These pads are readily available from your local hardware store.

DO NOT use a vacuum cleaner on the mat. The high speed rotating brushes can damage and scratch the surface.

DO NOT stand on the mat with stiletto style high heels. These sharp straight heels can potentially damage the surface of the mat. Additionally, stiletto heels do not provide enough surface area on a thickly padded mat for a stable foundation when working and could lead to injury.

DO NOT use window cleaners, floor cleaners, polishes, or all-purpose cleaners (such as Formula 409?) to clean your floor mat. If you need to clean the mat, use a mild dish washing detergent and water with a damp sponge or soft cloth. Never use abrasive cleaners or scrubbers of any kind as this cloud damage the surface of your mat.



When storing or packing your mats, **DO NOT** roll the mat with the bottom side out and do not fold the mat. This can create permanent wrinkles or uneven surface.

When mopping your floor or cleaning up a spill, please ensure that any liquid has dried before replacing the mat. Your floor mat is virtually waterproof, and as a result if surface is not completely dry before replacing the mat, water damage may occur on your floor surface or a slip hazard may occur.

WARNING: A RUG OR FOOR MAT CREATES A RAISED SURFACE ON THE FOOLR.

Floor mats create a raised surface on the floor. Any raised surface presents a potential trip hazard, and care should be taken while stepping on, over, or off a raised surface.

QUESTIONS & ANSWERS

1. How to clean and maintain the product? Use the cloth to clean the surface of the product directly. The residue in the gap can be cleaned with a vacuum cleaner. Keep it as dry as possible during normal use. Avoid long-term exposure under the sun. The shelf life of the product is 1 year. Actual use depends on the environment. Up to 3-5 years.

2. Whether the product has anti-static, anti-slip, waterproof, acid and alkali resistance;

The product is waterproof, acid and alkali resistant, and has a non-slip layer or anti-slip structure at the bottom to prevent sliding, anti-static, anti-bacterial, special environmental protection requirements can be customized, the product can not contact organic solvents.

3. What should I do if the product has an odor? When the product uses NBR anti-slip net and bonding process, there is a volatile odor of PU glue remaining, which can be placed in a well-ventilated place for a few days, which can basically remove the odor.
